Please review the following User Agreement carefully before engaging with NSCD's online Learning & Participation programme. STUDENTS WHO ARE UNDER 18

All students who are under 18 should be fully supervised by an adult when engaging in our online classes & must be supervised in the setup of all accounts to access this work.

HEALTH & SAFETY WAIVER

NSCD strongly recommends that if you have concerns about undertaking any physical activity or have an existing injury, that you will have consulted with your GP before beginning any of the physical aspects of the programme of study.

NSCD is not a licensed medical care provider & represents that it has no expertise in diagnosing, examining, or treating medical conditions of any kind, or in determining the effect of any specific exercise on a medical condition.

You should be in good physical condition & be able to participate in the exercise. You should understand that in certain circumstances (e.g. if you are carrying an injury, disclosed or otherwise) that some activities may be unsuitable for you. In this instance, you should seek staff guidance around making reasonable adjustments or modifications to the material before undertaking the class.

It is important, for us that you understand that when participating in any aspect of physical activity online or otherwise, there is the possibility of physical injury. If you engage in online classes, you agree that you do so at your own risk; you are voluntarily participating in these activities, assume responsibility for all risk of injury to yourself, & agree to release & discharge NSCD from any & all claims or causes of action, known or unknown, arising out of NSCD negligence.

We are advising you that you should disclose any medical condition or the taking of any medications which is beyond what we already know about that may affect your ability to engage with our online programme. If during the online class your health worsens we advise that you seek medical advice & support immediately & notify us of any outcome.

Under no circumstances should you attend any online session whilst under the influence of / or suffering from the effects of alcohol or illegal drugs.

By booking onto the online classes, you (the participant), the school & its staff, agree that NSCD shall not be held liable for any type of loss or damage that could be construed as arising from this programme. NSCD does not take any responsibility for inappropriate engagement, use or application of information or instruction provided through online materials.

CREATING A SAFE WORKING SPACE

To support safe practice we recognise that you will have undertaken the online risk assessment procedures & risk assessment, which is part of the online form link at the bottom of this document.

VIDEO CONFERENCING

Video conferencing using applications such as zoom, skype & face time are going to be common place in our remote connections. You agree to only create an account using your parent / guardians email address & not use social media such as Facebook or google to log into video conferencing.

You must have video camera in operation at the start of the meeting, so that the host can verify who you are, otherwise you will not be able to enter the meeting 'room'.

You must not attempt in any way to record the class & you must not invite others into the meeting at any time.

You are responsible that no minor e.g. a sibling enters the frame (otherwise host recordings as a later resource become void & unusable).

When entering a class you should arrive 10 minutes early, where you will be held in a 'waiting room' until the host arrives. You should enter the meeting with your microphone on 'mute' until a time when you are invited to speak.

ACCOUNTS & PASSWORDS

Participants must not disclose or share their account details & password with others, & will notify NSCD if they believe that someone has gained access to their passwords.
