# CAT@NSCD

The curriculum at NSCD is intended to give students a strong basic grounding in technical and creative skills, as well as an introduction to the wider dance profession; it includes tuition in five key areas:

- Technique
- Creative dance and choreography
- Performance
- Dancers' health and wellbeing
- Cultural activities such as theatre and gallery trips, workshops and volunteering opportunities.

The scheme equips our dancers with the necessary skills to progress on to professional vocational dance training.



## Weekly Classes

- Our Centre for Advanced Training students attend a minimum of 8 hours per week outside of school hours:
- 2 classes in the evening mid-week (ballet and contemporary technique)
- 3 classes on a Saturday (contemporary technique, creative / choreography and complementary study)

#### Assessment and Feedback

Each student has an Individual Training Plan and assessment evidence is collected through:

- Continuous and summative assessments in technique modules, creative and performance modules including rehearsal processes
- Written /verbal project reports and evaluations / reflections
- Individual and small group verbal presentations

Students receive ongoing feedback in practical classes and through the tutorial system

### Support

We also offer support for our students in the following areas:

- Assessment with a registered osteopath / physiotherapist
- Financial support packages for those in receipt of a DfE grant for travel and equipment / clothing
- Counselling advice and guidance
- Injury & rehabilitation support

# Department For Education (DfE) Grants

The DfE offer grants which are means-tested based on family's annual earnings per tax year, with deductions and allowances made for dependents in accordance with their guidelines.

Families' financial circumstances are reviewed annually, and support is available to families whose income falls below £68,506 per annum (2019/2020). Students who are eligible and who make sufficient progress will be entitled to receive financial assistance until they graduate or exit from the programme.

# Stage 1 & Stage 2 Auditions

### Stage 1

This session enables potential students and their families to learn more about the scheme. The online session includes an introductory presentation to the scheme followed by guidelines on how to complete the online application process & the remote audition.


Applicants will then be notified if they have been selected to go through to stage two of the audition process within two weeks of the deadline.

### Stage 2

Firm plans have not been set for Stage 2 at this point in time as we are awaiting further government guidance. But we have two options;

- 1. Face to face including a contemporary technique and improvisation class, followed by individual solo performances and group interviews.
- 2. Remote audition with a live Zoom session including a contemporary technique class, a creative class & group interviews. Plus a pre recorded solo to be submitted.

Successful auditionees from this round will be offered a coveted place on the NSCD CAT scheme.



# Remote Auditions (Stage 1)

### Getting to know you

Footage of you talking which should include:

A short introduction of yourself, including your name, age and why you would like to join the CAT programme, this should be a maximum of 3 minutes.

### **Contemporary Technique**

Learn and record yourself doing

Learn a phrase 1 as demonstrated in a link that will be sent to you to learn.

#### **Creative Task**

In order to assess your creative skills and ability to respond to instruction we ask that you explore a creative task & then create a phrase of movement that lasts no longer than 1 minute.

Fill in all the information on the form and at the end of the form upload your links to your recorded footage — this could be You Tube / Vimeo etc — please make sure your recordings are unlisted
